# MEMBERSHIP TYPE QUALIFICATION CRITERIA

## TRANSFER MEMBERS

Members who transfer within 12 months from another club into the chartering club are considered transfer members and pay a transfer charter fee of US\$20. Transfer charter members must be transferred in good standing from the former club to qualify for transfer member status.

## FAMILY MEMBERS

The Family Membership Program provides families with the opportunity to receive a special dues discount when they join a Lions club together. The first family member (head of household) pays full international dues (US\$43), and up to four additional family members pay only half the international dues (US\$21.50). All family members pay the one-time charter fee of US\$35.

The Family Membership Program is open to family members who are (1) eligible for Lions membership, (2) currently in or joining the same club, and (3) living in the same household and related by birth, marriage or other legal relationship. Common household family members include parents, children, spouses, aunts and uncles, cousins, grandparents, in-laws and legal dependents.

Family membership is limited to no more than five qualifying members per household, and new clubs must have a minimum of ten full-paying members. Same-household residency is not required for family members under age 26 if they are pursuing higher education or serving in their country's military.

## STUDENT MEMBERS

Students between the age of legal majority and through age 30 joining any type of Lions club qualify for the Student Member Program and pay no charter fee and half international dues. Students over age 30 and joining a Campus Lions club pay a US\$10 charter fee and full international dues.

Students of new Campus Lions clubs, or clubs with a majority of students, must prepay one year of international dues at the student member rate.

## LEO LIONS/FORMER LEOS

All former Leos receive a charter fee waiver. Former Leos between the age of legal majority and through age 30, who have been a leo for at least a year and a day, are considered Leo Lions, and pay only half international dues. Submit the *Leo to Lion Certification and Years of Service Transfer Form* (LL-2).

## YOUNG ADULTS

Young adults, through age 30, receive a charter fee waiver and pay half international dues when joining a Leo Lions club with at least 10 former Leos. Submit the *Leo to Lion Certification and Years of Service Transfer Form* (LL-2).
