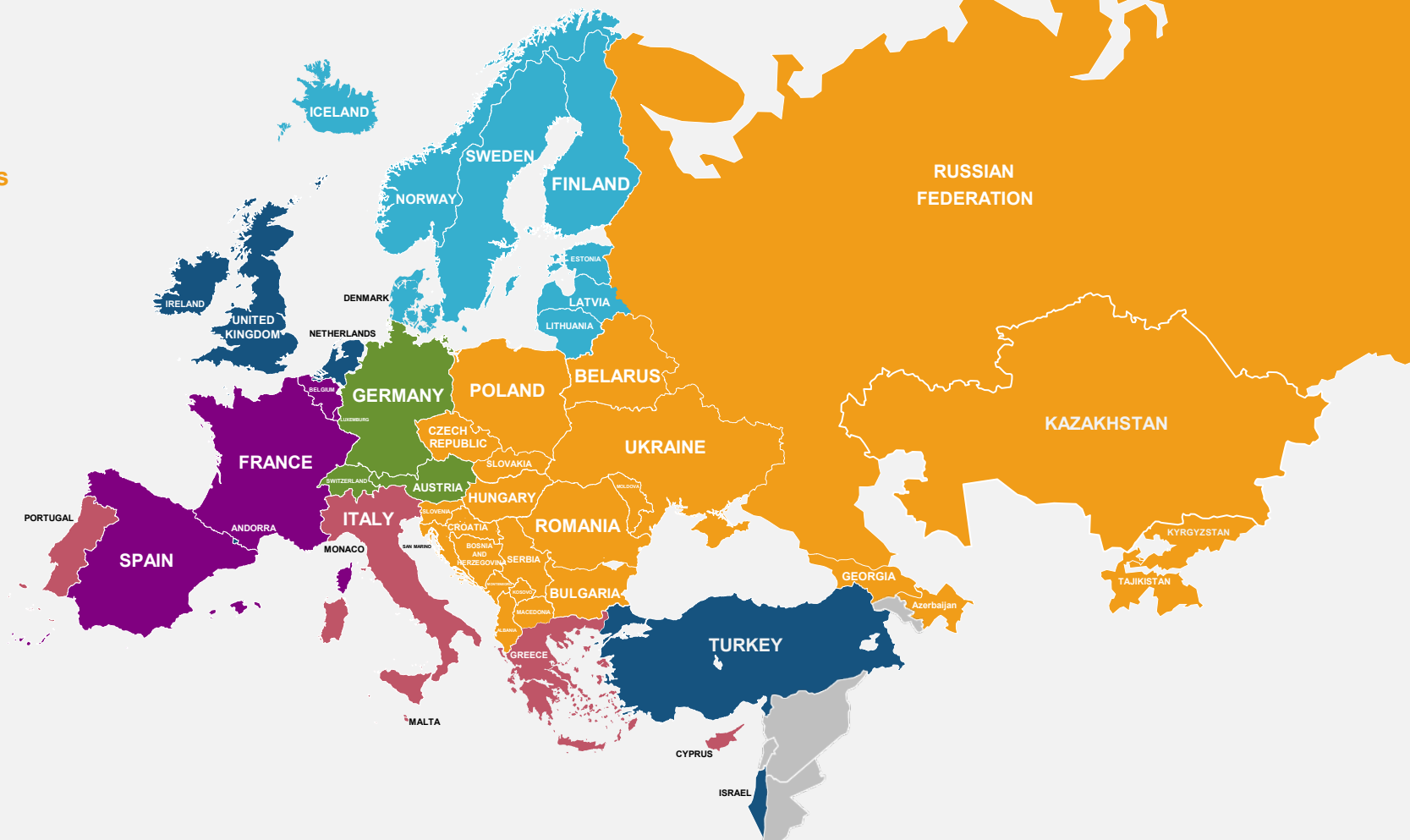

Build a plan as a team to achieve the established vision.

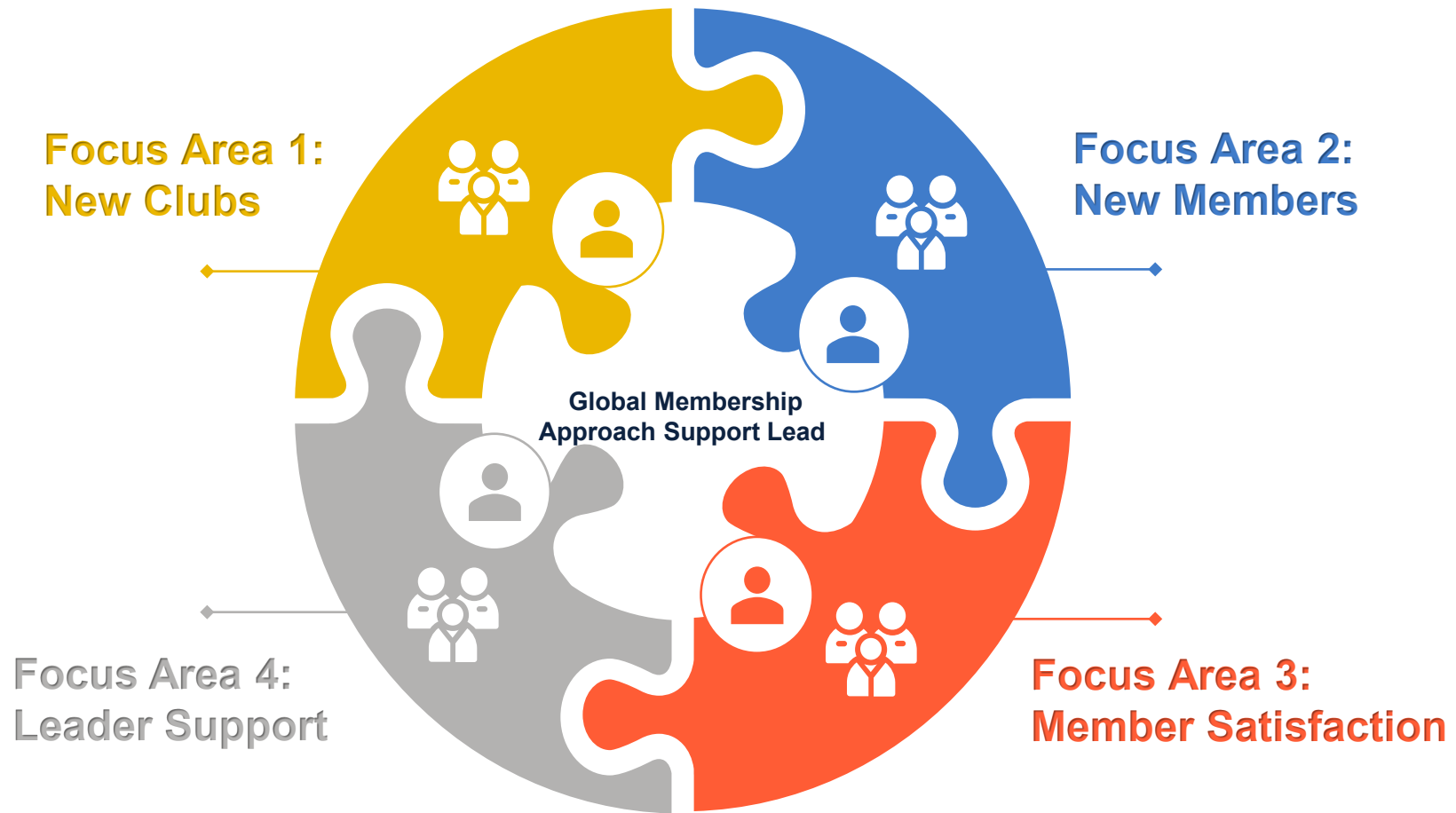

Lessons Learned with GMA Pilot Districts

- Create clear focus areas and **communicate regularly with the organization.**

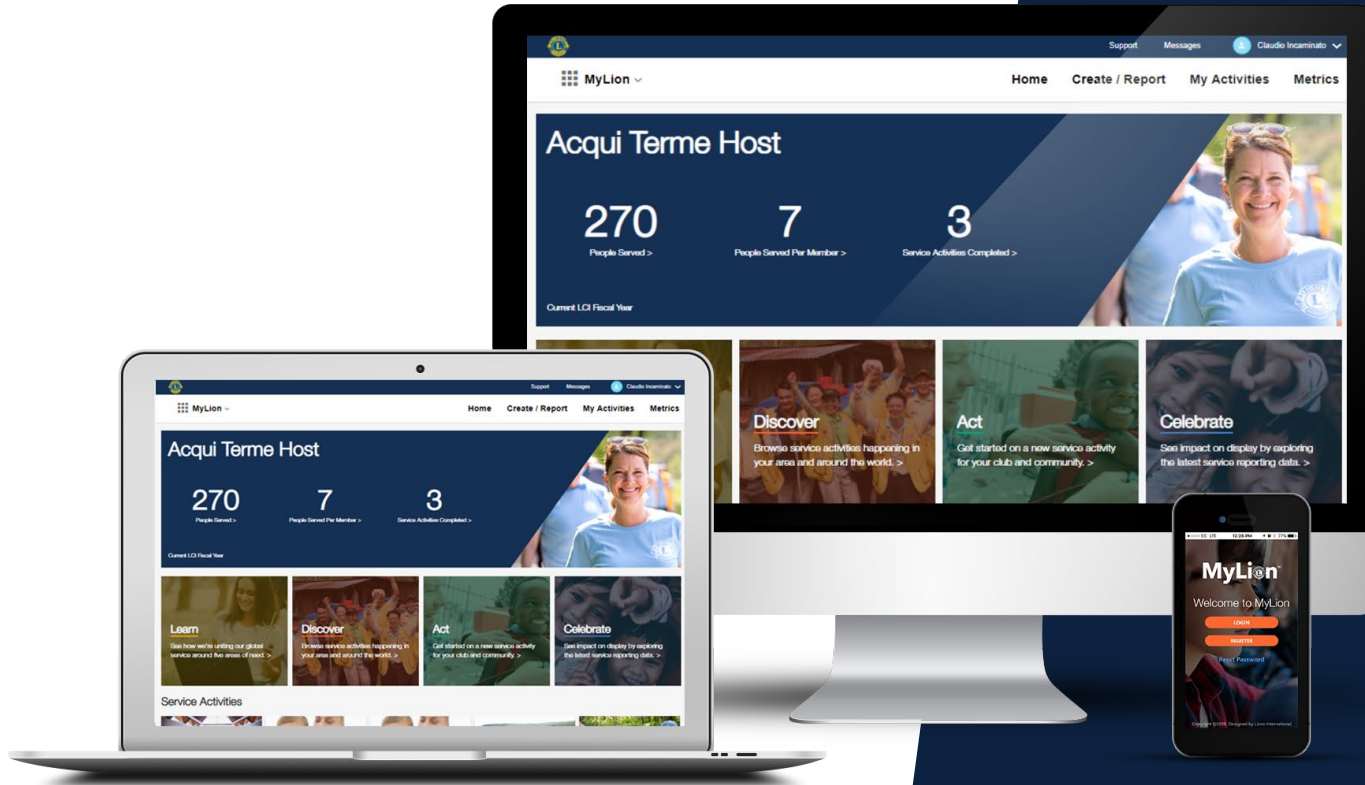
Why is the GST important?

Leo Districts

Storytelling is the best way to share and celebrate success while receiving funds to support the needs of your area.

BASIC INFORMATION

What: US\$350 per Leo district
Who: All Leo districts
Where: Apply online
When: No later than May 1

Leo district submissions must be made by the Leo district president or district Leo chairperson on record with Lions International to be eligible for funding.

REQUIREMENTS

To receive success story funding, the submitted story must:

- ☒ Be in your own words
- ☒ Focus on service, membership and/or leadership
- ☒ Be a minimum of 350 words in length
- ☒ Have occurred within the past 3 years
- ☒ Describe the results or outcome of the story
- ☒ Show an impact, inspire someone, or allow the audience to learn something

Undistricted area submissions must be made by the Coordinating Lion on record with Lions International to be eligible for funding.
