EXECUTIVE SUMMARY LIONS CLUBS INTERNATIONAL FOUNDATION BOARD OF TRUSTEES MEETING

1. Amended the LCIF Operations and Policy Manual to name Arijit Sen as the fiscal agent for India, effective July 30, 2018 (Chapter II - Operations, Paragraph H.6).

AUDIT COMMITTEE

1. Reviewed the internal audit process and current projects.

DEVELOPMENT COMMITTEE

- 1. Reviewed LCIF fundraising achievements for 2017-2018 totaling US\$52,574,014 in gifts and pledges (unaudited).
- 2. Discussed strategies for donation types for Campaign 100: LCIF Empowering Service, including lead and major gifts; mid-level gifts; planned gifts; club gifts; corporate, foundation and government donations; and Leo fundraising.
- 3. Approved a staff expansion plan for the Development and Donor Services departments to adequately align staff with Campaign 100 goals.
- 4. Amended the LCIF Operations and Policy Manual as follows:
 - reduced donation recognition levels of the Lions Share Program from US\$100, US\$200, and US\$300 to US\$50, US\$100, and US\$200 (Exhibit D, Paragraph VI)
 - approved housekeeping changes to bring policy in line with current practices that allow multiple forms of recognition for a single donation (Chapter II Operations, Paragraph K)

FINANCE COMMITTEE

1. Approved a decrease of US\$451,932 to the overall capital fundraising campaign budget.

MARKETING COMMITTEE

- 1. Reviewed the three-year strategic marketing plan for Campaign 100, focusing on the 2018 international convention launch and year-one strategies and tactics.
- 2. Received an update on recent, current and upcoming LCIF marketing and communication programs.

PROGRAMS COMMITTEE

- 1. Approved 43 grants totaling US\$2,022,843.
- 2. Tabled four grants for reconsideration at the January 2019 meeting.
- 3. Denied one grant.
- 4. Approved a US\$1,756,700 grant for the LCI-Special Olympics "Mission: Inclusion" Partnership 2019 activities.
- 5. Approved that the moratorium for the consideration of grants for District 317-D (India) be lifted.
- 6. Requested that District 334-E (Japan) submit letter of apology and return US\$172,000 in grant funding by October 15, 2018. If deadline is not met, further action will be taken.
- 7. Approved a US\$450,000 grant to support the Research to Prevent Blindness (RPB)/LCIF Basic Science Low Vision Award for another three years.
- 8. Approved a US\$37,965 grant to support the purchase of vision screening equipment for a World Sight Day service project in California on October 19, 2018.
